A certified QMS helps us achieve this and ensure that design, products, and methodology meet project requirements, regulatory benchmarks, and client specifications, not to mention strengthen value-add propositions and increase the likelihood for potential partnerships with foreign and local players,” he added.

For Hennig, receiving the ISO 9001:2015 is part of the company’s journey towards sustainable growth and operational excellence. The Company is constantly enhancing its operational capabilities and sharpening its competitive edge to expand its role in the country’s infrastructure build-up.

#### **Ongoing infrastructure pivot**

Megawide, together with its Japanese partners Tokyu Construction and Tobishima Corporation, recently signed Contract Package 104 of the Metro Manila Subway Project. It is also fast expanding its transport-centric development (TCD) portfolio, anchored on a hub-and-spoke model, with the country’s first landport, PITX, currently at the core. Megawide is also modernizing Cebu’s 100-year old Carbon District, including its public market, through a joint venture with the Cebu City Government.

As part of the Company’s drive for outstanding workmanship and industry leadership, Megawide has also received other certifications such as ISO 14001:2004 (Environmental Management System), OHSAS 18001:2007 (Occupational Health and Safety Management System), and the previous versions of ISO 9001, ISO 9001:2008 for its comprehensive approach to providing exceptional service and quality management.
